- A yearly meeting of the full EBC Analysis Group that brings together members of the EBC Analysis Group and experts from each individual Sub-Committee to reflect on upcoming analytical challenges of the brewing sector and how the EBC Analysis Group can best address them through its work plan.

Experts will input into the development of new methods used as reference by the brewing industry. They will have the occasion to cooperate and organize collaborative trials which would increase their networking with other professionals from the industry, be it brewers or suppliers. Their contribution will be recognised in the different EBC publications.
